LB43/23/24 - TO RECEIVE APOLOGIES OF ABSENCE

Apologies had been received from Cllr Wright and Cllr Brown.

LB44/23/24 - DECLARATIONS OF INTEREST

None had been received.

LB45/23/24 - TO RECEIVE APPLICATIONS FOR DISPENSATION

None had been received.

LB46/23/24 – TO APPROVE THE MINUTES OF THE MEETING OF 18th JULY 2023

It was AGREED: That the minutes of the meeting held on Tuesday, 18th July 2023 be approved as a true record and signed by the Chairman.

LB47/23/24 - PUBLIC FORUM

Four members of the public were present at the meeting and the following items were raised:

- Drainage on Bramford Road. Highways had been contacted but no works had been undertaken to rectify the problem. It was explained that the main drain that went to the Gipping had damage therefore causing water to spurt out of the drain during wet weather. Cllr Chambers asked that photographs be sent to him of the problem so he could address it with the Highways department.
- Noise and planning issues Lukes Meadow, Little Blakenham. Residents had raised concerns about constant noise pollution from the site and also there had been concerns that construction had taken place without planning permission being sought. Cllr Marriott stated that she would look at the site and look into the issues.
- Port One large mountain of soil on the site was causing a slurry to form during wet weather. The slurry would then make its way down from the site and if it was not managed it would eventually run towards the dual carriageway. Cllr Chamber stated that he would make contact with Port One in relation to this issue.

 Bee Orchids were present on the Port One site, at the wooded area to the right of the brow of the hill on Pound Road – they needed to be protected. Cllr Chambers stated that he would also raise this with Port One.

LB48/23/24 - TO RECEIVE THE COUNTY COUNCILLOR'S REPORT - CLLR CHRIS CHAMBERS

Cllr Chambers reported that the current RAAC concrete issues within schools had badly affected Claydon High School which had resulted in them closing 14 classrooms. They had arranged for some mobile classrooms to be put in the car park area to use on a temporary basis.

He added that five school in Suffolk had been affected by the RAAC problem.

Outstanding issues for Little Blakenham:

- 'Village Hall' directional sign for Valley Road Cllr Chambers reported that he had spoken with Highways but the sign would not be a priority and would be extremely expensive.
- Pound Lane HGVs Cllr Chambers reported that following conversations with the Highways Department, the best way forward initially, would be to enlarge the 'unsuitable for HGVs' signs.

Cllr Palmer stated that if HGVs continued to use Pound Lane, it would damage the highway which would then be a much larger job for the Highways team to repair.
