LB45/24/25 – TO RECEIVE APOLOGIES OF ABSENCE

Apologies had been received and approved from Cllr Palmer and Cllr Binder.

LB46/24/25 – DECLARATIONS OF INTEREST

None had been received.

LB47/24/25 – TO RECEIVE APPLICATIONS FOR DISPENSATION

None had been received.

LB48/24/25 – TO APPROVE THE MINUTES OF THE MEETING OF 16TH JULY 2024

It was AGREED: That the minutes of the meeting held on Tuesday, 16th July 2024 be approved as a true record and signed by the Chairman.

LB49/24/25 – PUBLIC FORUM

Five members of the public were present. The following issues were raised:

- Public FPs overgrown footpath from Valley Road to Leather Bottle Hill needed work to be carried out as concrete and metal pieces litter the footpath making it dangerous to use – County Cllr Chambers asked for the details to be sent to him and he would look into the issues.
- Bus stop graffiti in the past it had been painted
- Streetlight opposite 37/38 The Beeches had been repaired
- Footpath bridge broken and steps to the main Somersham Road needed attention
- Speed limits in village concerns over the level of speeding motorists along Valley Road with horse riders and pedestrians having near misses in recent months. During closure of Somersham Road vehicles drive along Valley Road which included large Lorries.

Man Orchids – it appeared that these had been cut along the Roadside Verge 119. The verge
markers were missing and had been reported to the Roadside Verge Reserves Department but
nothing had yet been done. County Cllr Chambers asked for more information so he could
investigate further.

LB50/24/25 - TO RECEIVE THE COUNTY COUNCILLOR'S REPORT – CLLR CHRIS CHAMBERS

Cllr Chambers briefly went through his report, which would be published on the village website. The main subjects included in the report were as follows:

- New Europa Way link road in Ipswich gets start date
- Major Scrapyard fire most likely sparked by discarded battery
- Solar Together launches in Suffolk
- Small improvements needed as Children's Services Ofsted report published

LB51/24/25 - TO RECEIVE THE DISTRICT COUNCILLOR'S REPORT - CLLR ADRIENNE MARRIOTT

Cllr Marriott briefly went through her report, which would be published on the village website. The main subjects included in the report were as follows:

- Councils to host call for land summit in September
- Additional funding approved to allow vulnerable residents to stay in their own homes
- Remediating unsafe buildings
- Household Support Fund extended six months
- Reminder Flu vaccination programme
- Reminder Respiratory syncytial virus vaccine toolkits

- Fuel Poverty in England report published
- Water Bill compensation
- MSDC Suffolk Recycles campaign
- Batteries and Electrical Fires

LB52/24/25 – SPEEDING – VALLEY ROAD

As mentioned earlier in the meeting, residents raised concerns in relation to the speed of vehicles along Valley Road.

Cllr Browne agreed with the concerns and stated that the road should not be 60mph due to its blind corners, hedgerows and pedestrians that used the road.

Cllr Chambers informed the meeting that whilst Valley Road was 60 mph, it did not mean that that was the speed motorists should drive and it would be down the driver to drive according to the road and surroundings.

He added that he noted the concerns raised and would fund a traffic monitoring survey, which would entail cables being placed across the road. These would track the speed of motorists for a certain period of time. He would arrange for this to be carried out as soon as possible.

He explained that there was a lot of criteria that needed to be met in order for the speed limit to be changed but the traffic monitoring survey would be the first step.

LB53/24/25 - TO RECEIVE THE CLERK'S REPORT AND FINANCIAL MATTERS

LB56/24/25 – PLAY AREA

Cllr Brown suggested that new play equipment needed to be purchased for the play area and different bits of equipment suggested, such as a slide.

The Clerk suggested that quotes be sought and an application for the District Council's CiL pot be considered.

Following a brief discussion members agreed that Cllr Brown would research new equipment and in October when the next CiL round took place would apply for funding.

The Clerk reported that the Play Area Inspection had taken place and all equipment had been noted as low risk, apart from the wooden stepping stones, which were moderate risk. These needed to be monitored

It was AGREED: That Cllr Brown seek quotes for new equipment and apply for CiL money.

LB57/24/25 - VILLAGE HALL REFURBISHMENT UPDATE

Cllr Keen reported that a meeting was held on 15th August 2024 by Port One – Solar Panel offer and Port One Legacy Biodiversity Enhancement Fund (POLBEF). The minutes of which would be published on the village website. The meetings were due to be held every three months.

The Clerk reported that the completion of the extended Lease was ongoing.
