#### LB80/24/25 - TO RECEIVE APOLOGIES OF ABSENCE

Apologies had been received from Cllr Wright, Cllr Brown and County Cllr Chambers.

### LB81/24/25 - DECLARATIONS OF INTEREST

None had been received.

#### LB82/24/25 - TO RECEIVE APPLICATIONS FOR DISPENSATION

### LB83/24/25 – TO APPROVE THE MINUTES OF THE MEETING OF 19<sup>TH</sup> NOVEMBER 2024

**It was AGREED:** That the minutes of the meeting held on Tuesday, 19<sup>th</sup> November 2024 be approved as a true record and signed by the Chairman.

### LB84/24/25 - PUBLIC FORUM

13 members of the public were present.

The following points were raised and actions noted:

- Surface Water Drains Little Box Meadow Clerk to report to Highways
- Proposed Play Area Refurbishment/Replacement Suez application could be made Clerk to pass information on to Cllr Brown
- Extra parking needed at Little Box Meadow not enough spaces District Cllr Marriott would investigate
- Speeding on Somersham Road / Valley Road Speed Signs suggested Parish Council investigating
- 30mph sign at The Beeches remained in a poor state Parish Clerk to chase County Cllr
- Graffiti Bus Stop needed to be cleaned member of public had cleaned the timetable Parish Council to look into
- Iron posts holding the fencing up at the Play Area (2<sup>nd</sup> and 3<sup>rd</sup> to the left of the gate) needed attention **Clir Binder would attend to**
- Re-routed traffic to Nettlestead extension of 30mph needed

- Soil needed to be reduced from The Beeches to the Bus Stop to enable safe walking along the verge to the Bus Stop
- Blocked ditches which had caused a rise in water levels and could cause serious flooding if landowners don't clear their parts of the ditch – Cllr Latham stated that The Beeches ditch would be cleared out by the farm contractor by the Spring.
